#### Approved Logos

- Club Sports teams must use approved logos:
  - Club Sports Medallion Logo
  - Sport Specific Logos
  - Tertiary Word Marks
    - Must have written approval from Brand Partnerships and Trademark Management
- Club Sports Logo Guide shows approved versions of all Club Sports logos.



#### Club Sports Medallion Logo

- When used, the entire logo must be visible.
- Cannot be modified from its current form.
- Must say CLUB SPORTS
  - Cannot be altered for specific team names.






## Club Sports Sport Specific Logos

- Teams can use the one-, two-, or three-color versions of their sport specific logo.
- Teams may change the colors of the logo to any approved version on the Club Sports Logo Guide.
- Cannot modify their team's name.




## Club Sports Logo Files

  - Files can be modified to the color combinations found in the Club Sports Logo Guide.




#### Approved Logo Usage

- Officers must ensure approved logos are used for the following (but not limited to):
  - Social Media
    - Team and League Posts
  - Team Websites
  - League Websites
  - Apparel
  - Uniforms
  - Fundraising Efforts
  - Posters, Flyers, Banners, etc.
  - Equipment



#### Club Sports Logo Usage Form

- Teams must fill out this form prior to ordering any apparel or promotional items with a UConn logo.
- Approval is needed when filling out funding requests.
- Form can be found on the Team Resources page and Fusion Club Resources.

#### Apparel Ordering

- Club Sports teams are REQUIRED to use BSN Sports for all apparel and uniform orders.
  - Teams MAY NOT seek out or contact any other vendors.

#### Additional RSO Guidelines

- As Registered Student Organizations (RSOs), Club Sports teams must also abide by the following:
  - Guidelines for Use of University Logos & Trademarks by Registered Student Organizations (RSO)
- Additional Restrictions include, but are not limited to:
  - Use of Husky Dog Logo (old or new) is not permitted.
  - Use of designs that try to mimic or create new husky dog designs is not permitted.
  - Use of the Official University Seal is not permitted.

#### Non-Compliance Penalties

- The non-compliance must be directly under the control of the team, including but not limited to: Social Media, Apparel, Websites, and Vendor Communication.
  - First Offense Email to correct/remove violation within 48 hours
    - If violation is not corrected in 48 hours, it will move to a Second Offense
  - Second Offense Written warning and a fine equivalent to 5% of their tier's budgeted amount from the Recreation Allocation
    - Contacting another vendor jumps directly to this level of offense
  - Third Offense Meeting with Coordinator and a fine equivalent to 10% of their tier's budgeted amount from the Recreation Allocation
  - Fourth Offense Team is placed on probation for one (1) calendar year
- Penalties are reset at the end of each Academic Year.
